- To expand vote by mail and early voting, and to improve the safety, accessibility, and efficiency of in-person voting during elections for Federal office.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "VoteSafe Act of 2020".

5 SEC. 2. FINDINGS.

- 6 Congress finds the following:
- 7 (1) The right to vote is the foundation of Amer8 ican democracy. Voting provides the citizenry with a
- 9 vital check on their elected officials and grants peo-

ple the political power necessary to exercise and de fend the rights guaranteed by the United States
 Constitution.

4 (2) The Elections Clause of the United States 5 Constitution gives Congress sweeping power to regu-6 late the time, place, and manner of Federal elections 7 (Article I, section 4 of the Constitution of the 8 United States; see also Arizona v. Inter Tribal 9 Council of Arizona, Inc., 570 U.S. 1 (2013)). Con-10 gress also has enforcement power under the Four-11 teenth and Fifteenth Amendments of the Constitu-12 tion of the United States.

(3) As Dr. Martin Luther King Jr. explained in
a speech delivered on May 17, 1957, "So long as I
do not firmly and irrevocably possess the right to
vote I do not possess myself. I cannot make up my
mind—it is made up for me. I cannot live as a
democratic citizen, observing the laws I have helped
to enact—I can only submit to the edict of others.".

(4) The right to vote was not guaranteed to all
Americans at our Nation's founding. The ratification
of the Fifteenth and Nineteenth Amendments, the
civil rights movement's struggle for justice and
equality, and the enactment of the Voting Rights

Act of 1965 and its subsequent amendments succeeded in expanding access to the franchise.

3 (5) Unfortunately, the barriers faced by voters
4 who have historically experienced the greatest obsta5 cles to voting are exacerbated by the coronavirus
6 (COVID-19) pandemic.

7 (6)mitigate the Strategies to spread of 8 COVID-19 include "social distancing", a practice 9 that requires individuals to maintain a distance be-10 tween themselves and other people in order to avoid 11 acquiring or transmitting the virus. The need to em-12 brace such precautions will require States to quickly 13 modify voting processes to minimize person-to-per-14 son contact.

15 (7) Voting by mail is a critical part of the solu16 tion and must be expanded as quickly as possible,
17 not simply as a means of ensuring access during
18 public health emergencies, but also as a means of ex19 panding access to the franchise to those whose work,
20 health, or ability to access the ballot may be limited.

(8) However, safe and secure in-person voting
remains vitally important for large groups of voters,
including voters with disabilities, language minority
voters, American Indian and Alaska Native voters,
and African American voters.

1 The Americans with Disabilities Act of (9)2 1990 (42 U.S.C. 12101 et seq.) and the Rehabilita-3 tion Act of 1973 (29 U.S.C. 701 et seq.) require 4 that individuals with disabilities have equal access to 5 every aspect of the voting process. Vote-by-mail 6 poses various accessibility challenges for voters with 7 disabilities, including blind, low-vision, or other 8 print-disabled voters who may require in-person vot-9 ing or assistive technology in order to privately and 10 independently mark their ballots. Remedies for vot-11 ers with disabilities require an investment of re-12 sources to ensure State and local election websites, 13 online voter registration portals, and vote-by-mail 14 systems are accessible; that in-person voting loca-15 tions permit a safe, dignified, and accessible voting 16 experience; and that the right of voters with disabil-17 ities to a secret ballot is not sacrificed due to the 18 pandemic.

(10) Language minority voters face unique barriers to voting that require additional resources and
support to ensure full and equal access, including
additional resources to ensure local compliance with
the language minority voting protections in section
20 203 of the Voting Rights Act of 1965 (52 U.S.C.
10503) and greater language assistance services, in-

cluding additional bilingual or multilingual poll
 workers and election workers.

3 (11) American Indian and Alaska Native voters 4 face unique obstacles in a vote-by-mail system. Trib-5 al communities in rural areas often do not have tra-6 ditional residential mailing addresses and have lim-7 ited access to transportation. Tribal members have 8 distant rural post offices, slow mail routes, limited 9 numbers of post office operation, and too few post 10 office boxes. As a result, rural Tribal communities 11 require distinct voting accommodations to ensure 12 participation in a vote-by-mail system.

13 (12) Finally, in-person voting holds great sig-14 nificance for African American voters, for whom the right to vote was hard won. African Americans have 15 16 been excluded from the franchise through State and 17 local laws, poll taxes, voting literacy tests, physical 18 violence, and lynchings. For many African American 19 voters today, casting a ballot at one's polling place 20 is a solemn ritual that honors those who sacrificed 21 their safety and their lives in order to secure the 22 right to vote. However, COVID-19 poses substantial 23 risks to the African American population and has in-24 fected and killed African Americans in the United 25 States at disproportionately high rates, highlighting

longstanding inequalities in resources and access to
 health care.

3 (13) Social distancing designed to curb the COVID-19 pandemic will also greatly impact in-per-4 5 son voter registration efforts, including voter reg-6 istration drives and voter registration services re-7 quired by the National Voter Registration Act. Many 8 government offices, like State departments of motor 9 vehicles, are currently closed to in-person traffic and 10 are likely to remain closed for an indefinite period 11 of time in 2020.

(14) Therefore, it is appropriate for Congress
to expand no-excuse absentee vote-by-mail while also
ensuring the safety and accessibility of in-person
voting and voter registration during exigent circumstances, including the current pandemic.
