Dear Speaker Pelosi, Leader McCarthy, Chairwoman Lowey, and Chairman Bishop:

The undersigned members of the Consortium for Citizens with Disabilities (CCD) Financial Security and Poverty Taskforce and Education Taskforce write in support of bill and report language which would strengthen the Supplemental Nutrition Assistance Program (SNAP) in the recently approved Fiscal Year (FY) 2021 Agriculture-Rural Development-FDA Funding Bill. CCD is the largest coalition of national organizations working together to advocate for federal public policy that ensures the self-determination, independence, empowerment, integration and inclusion of children and adults with disabilities in all aspects of society.

We strongly support the Committee's inclusion of both bill and report language in the FY 21 Agriculture-Rural Development-FDA Funding Bill which would block the U.S. Department of Agriculture's (USDA) Able-Bodied Adults Without Dependents rule (ABAWD) and the Standard Utility Allowance (SUA) rule. Additionally, we also support the corresponding bill report language which encourages USDA to withdraw the Broad-Based Categorical Eligibility rule (BBCE). We thank you for including this language and urge you include it in the final appropriations package. These three rules threaten access to SNAP for people with disabilities and for students with disabilities who are automatically eligible and directly certified for free school meals through participation in SNAP. CCD has previously opposed these rules as they would make it more difficult for people with disabilities to access needed nutrition assistance.<sup>1</sup>

As COVID-19 cases continue to surge in many parts of the country coupled with a bleak economic forecast for the foreseeable future, preserving and expanding access to nutrition assistance is critical during these unprecedented and unpredictable times. It is unconscionable that during a global pandemic that has resulted in economic uncertainty not seen since the Great Recession, USDA elected to proceed with the implementation of its damaging regulatory agenda. As recently as the third week in June, almost 18 percent of children in the US did not have sufficient food<sup>2</sup> and food bank leaders have expressed grave concerns about a food insecurity crisis as the economy continues to recover.<sup>3</sup> SNAP provides needed food assistance to millions of adults and children with disabilities and it is absolutely critical that access to SNAP be preserved and that desperately needed additional federal resources are provided in both FY 21 appropriations bills and the next COVID-19 relief package.

Again, we applaud the Committee for including this important language in the FY 21 Agriculture-Rural Development-FDA Funding Bill and urge you to include this language in any final appropriations package. As the pandemic runs its course, both adults and children with disabilities will need continued access to much needed food assistance.
