# Public Health Fellowship

Disability Rights Maryland (DRM) seeks a civil rights-oriented public health fellow for a full-time 1-year position to support our goal of advancing the civil and human rights of people with disabilities. This position is funded through a COVID-19 Response Public Health Workforce grant from the Administration on Community Living (ACL). An ideal candidate will share DRM's values and commitment to the fundamental rights of people with disabilities to maintain independence and full access to community life with freedom from abuse and discrimination.

<u>The fellow will work with DRM's Developmental Disabilities and Healthcare team</u>. The fellow will research and analyze COVID-19 related data on deaths, infection rates, staff shortages, pandemic related policies, and resident rights violations at state-funded institutions that serve people with disabilities. The fellow will also interview residents and patients of different facilities. The collected data and client stories will be the foundation for a COVID-19 report that the fellow will be responsible for drafting and seeing through its publication.

#### Minimum Qualifications for Public Health Fellow:

- Bachelor's degree from an accredited university.
- Ability to relate respectfully to people with disabilities. Experience working with and/or sensitivity to persons with disabilities and from diverse communities.
- Excellent attention to detail in work product.
- Ability to work independently, successfully manage multiple work priorities and work under deadlines.
- Strong interpersonal skills. Ability to establish and maintain effective working relationships and collaborate with DRM staff and colleagues in a team environment.
- Ability to maintain confidentiality and exercise sound judgment in the handling of all advocacy activities.
- Computer literacy and proficiency with software utilized to carry out job functions.
- Access to reliable transportation for travel within State of Maryland.
- Strong commitment to DRM's core mission of ensuring the rights of people with disabilities to self-determination, freedom from harm, due process protections, and to participate fully in community life with meaningful choices and opportunities.
- Strong data analysis, research and writing skills.

# Preferred Qualifications for Public Health Fellow:

- Master's degree from an accredited university.
- Academic experience in a related field, including public health, social work, , and legal studies.

- Relevant work experience is strongly preferred, particularly with data analysis, research, conducting investigations and interviews, and projects that required excellent organizational, interpersonal, and verbal and written communication skills.
- Experience working directly with persons with disabilities.
- A demonstrated interest or background in public interest work, particularly related to disability rights issues.
- Life experience with a disability.
- Fluency in American Sign Language or Spanish.

#### Salary and Benefits:

Competitive, depending on experience. The annual salary range for this fellowship for candidates with a Bachelor's degree and 0-5 years' experience is between \$43,603 and \$48,119 with increases for additional education level, experience, and special skills. Salary for a candidate with a Master's degree and 5-10 years' experience is between \$49,119 and \$53,635.

DRM offers a generous benefits package which includes excellent medical insurance, employerpaid dental, prescription, vision, life, and disability insurance, as well as pre-tax savings plans, a retirement savings opportunity with generous employer contributions, and a telecommuting policy. DRM offers employee reimbursement for some or all of the cost of spouse or partnerpaid health insurance premiums up to an established maximum amount. DRM also offers generous paid time off, including vacation, holidays, sick time, and more.
