

### Position Announcement Public Policy Analyst

The National Disability Rights Network (NDRN) in Washington, D.C., is seeking a public policy analyst to work with a team of colleagues throughout the organization to represent NDRN's policy positions with federal agencies and Capitol Hill. The Public Policy Analyst also works with NDRN member organizations and coalition partners to develop, implement, and coordinate legislative strategies to advance the federal policy work of NDRN.

**Who We Are**: NDRN is the nonprofit membership organization for the federally mandated Protection and Advocacy (P&A) Systems and Client Assistance Programs (CAP). P&As and CAPs exist in all 50 states, the District of Columbia, the five U.S. territories, and one in the Four Corners region affiliated with the American Indian Consortium. The P&A/CAP system is collectively the largest provider of legal services to people with disabilities in the United States.

NDRN provides training, technical assistance, and legal support to the P&A & CAP agencies and undertakes legislative advocacy to create a society in which people with disabilities are afforded equal opportunity and can fully participate by exercising choice and self-determination.

#### **Responsibilities include:**

- Works with the public policy team to develop and support the implementation of comprehensive engagement strategies and objectives to secure and/or reinforce protections for people with disabilities.
- Develops and disseminates public policy/legislative resource materials (reports, issue briefs, informational documents, etc.) to inform and

support NDRN leadership and membership.

- Develops and maintains productive relations with executive branch leaders and Congressional members.
- Monitors and analyzes proposed legislation, emerging issues, and trends and develops policy recommendations that support NDRN's mission.
- Works closely with external partners on task forces, committees, and coalitions and helps manage and strengthen relationships with external partners, including providing leadership on NDRN-led committees and coalitions.
- Provides technical assistance and/or training to NDRN membership, as needed.

# **Required Qualifications:**

- 1. Bachelor's degree and/or experience equivalent to a four-year college degree in public policy, legal or a disability-related field.
- 2. Two to four years' experience working with Congressional members and staff, especially concerning the appropriations process.
- 3. An understanding of federal disability policy, legislation, and issues.
- 4. Proven analytical and effective communication skills, including writing and presentation skills.
- 5. Ability to research and analyze issues and facilitate the development of creative solutions.
- 6. Strong interpersonal skills including, but not limited to, sensitivity to other people and the ability to work effectively in coalition with other groups.
- 7. Ability to work well in a team environment.
- 8. Demonstrated administrative skills and working knowledge of Microsoft 365.
- 9. Demonstrated commitment to the potential contributions of individuals

with disabilities and to efforts to make possible the realization of that potential.

### Location and Travel:

Location: Washington, D.C., following a hybrid policy.

The position requires some travel and occasional work on weekends.

### **Compensation and Benefits:**

NDRN offers a competitive salary based on experience. Benefits include a health plan; Flexible Spending Account, transit and parking benefits; 403(b) retirement plan; paid vacation and sick leave, and at least ten paid holidays.

The salary range for this position is \$65,000 to \$75,000.
